**Constitution changes:** The following are the suggested changes marked in red will be voted on at the meeting on the 12 January 2020.

11. FINANCIAL YEAR

The financial year of the Club shall conclude on the **31<sup>st</sup> day of December** in the year.

12. FUNDS

a) The funds of the Club shall be derived from, annual subscriptions of members, donations and subject to any resolution passed by the Club at a general meeting, such other sources as the Committee determines.

b) The funds of the Club shall be deposited in an account with a bank or building society and such account operated upon by any two of the President, Secretary and Treasurer. The income and property of the Club shall be applied solely towards the promotion of the objectives of the Club. No money shall be paid directly or indirectly to individual members of the Club unless by way of bona fide compensation for money spent or for services rendered on behalf of the Club, and then only if approved by the Committee.

13. SUBSCRIPTIONS

a) There shall be an annual subscription fee which the committee will determine from time to time. Annual subscriptions shall be payable on membership application. Annual subscriptions will be set **at before** the Annual meeting each year and will be due and payable by the **30<sup>th</sup> June annual meeting** each year, and any membership that is not renewed by the end of **September** **March** will be automatically terminated. This means that our subscription year is from **1<sup>st</sup> July to 30<sup>th</sup> June** **1<sup>st</sup> January to the 31<sup>st</sup> December** each year.

b) New members joining between the **1<sup>st</sup> of January and the 30<sup>th</sup> June** **30<sup>th</sup> June and 31<sup>st</sup> December** will automatically receive membership for following year as determined by the committee.

**18. CLUB PERMIT SCHEME**
