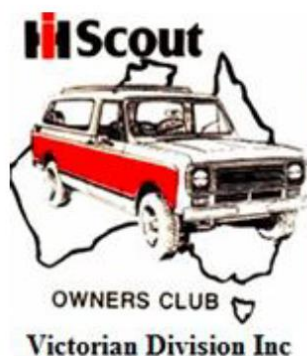

HOW TO PUT A VEHICLE ON CLUB PLATES WITH THE INTERNATIONAL SCOUT OWNERS CLUB, VIC DIVISION

GENERAL CLUB PERMIT RULES APPLICABLE TO ANYONE HOLDING A CLUB PERMIT

Maintain financial membership of the International Scout Owners Club, Vic Division Inc (ISOC Vic Div Inc). (The club), at all times whilst holding a club permit registration.

The vehicle owner must be a current financial member for at least 6 months before application will be considered.

The vehicle must be more than 25 years old.

Ensure that the vehicle is only used for private use and is not used for commercial use or return.

Ensure they are familiar with Vicroads and the club's requirements for club permit holders.

Ensure they are familiar with the log book requirements.

Maintain their vehicles in a manner which ensures that the vehicle is in a "safe" condition for use on public roads.

Present their vehicle for periodic safety checks if prescribed by their club.

Ensure that the log book and permit is carried in the vehicle at all times the vehicle is in use.

Ensure that the number plate(s) and windscreen label as issued by Vic Roads are correctly displayed on the vehicle at all times when the vehicle is in use.

A club permit vehicles may be driven by anyone who holds the applicable licence for the category of vehicle (including learner permit holders and drivers under instruction).

Club Permit vehicles may be driven throughout all States and Territories provided the vehicle complies with Victorian requirements for the holding of the club permit. Permit holders are encouraged to check particulars with relevant registration authorities before travelling interstate.

A modified vehicle must comply with the parameters of the Vic Roads instruction 'VSI 33' to be accepted under the historic category. Otherwise, the vehicle may be subject to the new Modified vehicle category regulations. See Vic Roads for further information.

An unmodified vehicle will require the following documents to be completed and presented to a Club Plate Scheme (CPS) Officer at regular meeting of the club or by arrangement with CPS Officer wherein an appointment may be necessary.

- a. Vic Roads Club Permit application form.
- b. Current certificate of roadworthiness.
- c. Completed Victorian Club Permit Application
- d. Current proof of membership
- e. \$30 admin fee (renewals & transfers \$10)

The applicant shall reimburse any travel costs incurred by the CPS Officer to the officer if the vehicle is not presented at a meeting or at a location not convenient to the Officer.

The vehicle must be presented to ISOC Vic Div Inc for identification and photographing when submitting completed documents. This is a Vic Roads requirement.

Assistance can be provided in completing the relevant forms if necessary. All I ISOC Vic Div Inc forms are available from the CPS Officer in your area or the Club Secretary. Vic Roads permit applications can be obtained from any Vic Roads office or downloaded from their website www.vicroads.vic.gov.au

Upon successful application, appropriate membership ISOC Vic Div Inc CPS fees paid in full and the required photographs taken, the CPS Officer will sign the Vic Roads Club Permit application, along with a Vic Roads Vehicle Eligibility & Standards Declaration form.

The vehicle owner must then present the completed and signed Vic Roads Club Permit Application, Vehicle Eligibility Declaration Form and the original RWC to a Vic Roads Office and pay the relevant permit fee applicable to a 45 or 90 day permit. (The vehicle does not need to be presented to Vic Roads staff unless requested by Vic Roads).

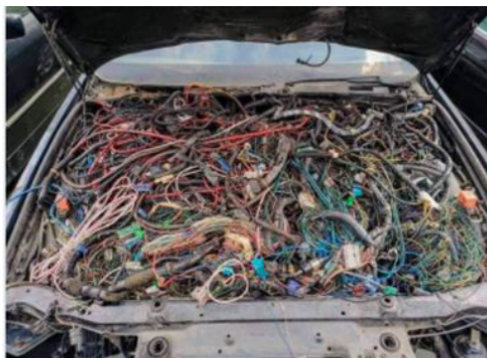
Upon receipt of a Vehicle Permit Plate from Vicroads (red plate), ISOC Vic Div Inc must be advised of the plate number. Email to CPS Officer at ute253@hotmail.com or Phone the CPS Secretary on 0408142271.

PERMIT RENEWALS.

Permit renewals will only be processed at club meeting dates. If you are unable to attend, your Vic Roads renewal form, Vic Roads Club Permit Scheme/ ISOC Vic Div Inc Renewal Declaration, ISOC Vic Div Inc CPS Permit fee and a stamped self-addressed envelope can be posted to 10 Reservoir Road Toongabbie Vic 3856.

Forms must be received early enough to give the CPS officer adequate time and mail time to process the forms. ISOC Vic Div takes no responsibility in delays in processing forms.

Once signed and returned, you will need to lodge them at Vic Roads and pay the appropriate fee.
